A team led by Scotch whisky industry veteran Billy Walker acquired The GlenAllachie Distillery in October 2017 with the intention of creating a boutique Scotch whisky company that is truly independent, Scottish-owned and managed.

Billy Walker, Graham Stevenson, and Trisha Savage, who came together as The GlenAllachie Distillers Co. Limited, have plans to release a range of aged whiskies from a 10-year-old to a 25-year-old. Across the senior team, the new owners have over 100 years’ experience in the Scotch whisky industry.

The GlenAllachie Distillery, sitting in a 20-acre site in Speyside, was designed by architect William Delmé-Evans and built in 1967. It has four stills and, unusually, two separate spirit safes, one for each set of stills.

“At fifty years old, it may be one of the younger distilleries on Speyside, but the range of casks we have warehoused is tremendous, with whisky dating back to the 1970s,” said Walker, Master Distiller for GlenAllachie. “We are looking forward to bringing classic GlenAllachie single malt to a new generation and exploring how we can deliver new blends that will become classics of the future.”
